

## ISM-Position Responsibilities

<b>Post</b>	:	<b>Boatswain</b>
Immediate superior	:	Chief Officer

---

### **Responsibilities:**

The holder of this post is performing duties of the deck department under supervision of and according to Chief Officer's advice and order. He is in charge of preparation of weekly and daily working programmes for Deck Ratings to ensure proper performance of maintenance activities and watch duties during respective voyage. He is also responsible for the control of maintenance work on hull, deck, deck machinery, equipment and deck inventory.

He assigns Deck Ratings for sea-/port watches and for performance of orders from Chief Officer or Officer on duty.

In his capacity as superior of the Deck Ratings the Boatswain is responsible for the compliance with all relevant ship safety, occupational health & safety and environmental protection requirements in his field of duty.

### **Authority:**

**Post** : **Deck Rating (AB, OS)**

Immediate superior : Boatswain

---

### **Responsibilities:**

Deck Ratings, who are assigned as watch keeper, have to support the Officer of the Watch (OOW) in respect of a safe operation of the vessel during sea watch and in the harbour as instructed by the OOW.

The AB and OS are assigned to perform maintenance and repair work in the Deck Department as per instruction of the Boatswain.

Duties in respect of security are to be performed according to instructions of the responsible Ship Security Officer.

Apart from being proficient in all aspects of deck duties and general purpose, Deck Ratings have added duties as e.g. steering the vessel, making rounds on the ship for monitoring general safety & security issues, manning the gangway and checking the mooring in port.

The Deck Rating is responsible for ensuring the proper use and care of personnel safety equipment, deck equipment, supplies and material.
